

2024 Scott E. Smith Salty Salmon Foundation, Inc. Scholarship

The Award:

The Scott E. Smith Salty Salmon Foundation Scholarship Committee awards scholarships in the amount of \$3,000 to be paid to the educational institution.

Eligibility:

The applicant must be a participant in a high school lacrosse program recognized by the appropriate state lacrosse association who meets all of the following criteria:

- The applicant is a college bound high school senior at the time of application.
- The applicant will be enrolled in either a two or a four year accredited educational institution.
- The applicant intends to participate at this institution in a lacrosse program recognized by one of the governing bodies for collegiate varsity or club lacrosse (NCAA, MCLLA, NJCAA, and NCCL).

Apply:

To apply, eligible applicants must complete the attached scholarship application form.

1. The signed application must be submitted with:
 - a high school transcript documenting the student's GPA for grades 9-12;
 - SAT/PSAT/ACT transcript (obtained through the school guidance office);
 - and
 - a typed essay response.
 - a letter of recommendation from the student's current lacrosse coach.
 - additional letter(s) of recommendation will be accepted but are not required.
2. The applicant and his parent/guardian must sign the Certification and Release Authorization on the last page of the application.
3. The application, transcripts and essay must be returned to the Scholarship Committee by *June 30, 2024*.

Selection Process:

Judging will be based on both subjective criteria and weighted, objective criteria. These include academic performance, lacrosse development, demonstrated leadership, community involvement, recommendations and the essay.

Application Deadline

Applications must be returned to the scholarship committee no later than June 30, 2024.
